Dear Chief Secretary,

Please refer to my earlier D.O. letter of even number dated 21<sup>st</sup> June, 2018 wherein I had shared the details of web based applications (MIS) developed by the Ministry for the DBT schemes and requested to adopt and use these applications for implementation of the DBT Schemes from the month of June, 2018 onwards. However, it is a matter of great concern that most of the States/UTs/Implementing agencies have not even started using the web based applications and the data inputs of June, 2018 are very poor for most of the States/UTs.

2. I would like to reiterate that manual progress reporting of DBT schemes in the DBT Bharat Portal has been disabled from the month of July, 2018 onwards and the web services will push data of June, 2018 onwards automatically in the DBT Bharat Portal on 7th of next month. It is, therefore, imperative that field level functionaries use the MIS exclusively for all DBT schemes without exception.

3. As you are already aware, the progress of implementation of DBT in welfare schemes is being closely monitored by Cabinet Secretariat and reviewed by PMO. I would, therefore, again request you to issue strict instructions to the concerned officers/officials in you States/UTs to adopt and use these web based application developed for DBT Schemes. 4. I would also like to invite your attention to my earlier D.O. letter No. DBT/2/2018-DBT Cell dated 19<sup>th</sup> February, 2018 wherein I had informed that the Ministry had already released Central Share in December, 2017 for procurement of three Aadhaar enrolment kits for each CDPO to set up permanent Aadhaar Enrolment Centres. It was also emphasised that the Aadhaar Enrolment Centre are made fully operational by the end of March, 2018. However, most of the States/UTs, particularly NER States, have not yet procured Aadhaar Enrolment Kits.

5. Further, to facilitate Aadhaar enrolment and related services of beneficiaries of DBT schemes, I had suggested in my D.O. Letter No. 12/35/2015-CD-I-Part (2) dated 15<sup>th</sup> November, 2017 that the WCD/Social Welfare Department of all States/UTs become Registrar under UIDAI and notify the CDPOs as Enrolment Agents. However, as per intimation received from UIDAI, majority of the WCD/Social Welfare Department in States/UTs are yet to become Registrars and notify the office of CDPO as Enrolment Agents.

6. I would, therefore, request you to kindly personally intervene in the matter and issue strict directions to the concerned Officers/Officials for immediate compliance of the issues mentioned above.
