Dear Chief Secretary,

I would like to bring to your notice the directions of the Central Information Commission (CIC) on mandatory voluntary disclosure under Section 4 (1) (b) of the RTI Act. The CIC in its Order, dated 10.07.2018 (copy enclosed) in the matter of Myathiari Janardhan Vs. PIO, MOWCD, has directed this Ministry to issue necessary guidelines to all Child Development Project Officers (CDPOs) under Anganwadi Services/ICDS Scheme for voluntary disclosures as per the mandate under Section 4 of the RTI Act.

2. The CIC requires all CDPOs under Anganwadi Services/ICDS Scheme across the country to voluntarily disclose/display/publish the month-wise expenditure incurred for functioning and maintenance of Anganwadi Centres, names of the beneficiaries, details of benefits and the minutes of meetings regularly on their websites and display the printed copies conspicuously on notice boards.

3. The CIC has further directed that every welfare information, relating to subsidies, concessions or free supply of medicines or nutrients given to children, pregnant women, nursing mothers, newborn children with name, dates and particulars of benefits shall be displayed on notice board along with timelines and availability periods both in English and regional language of the area and also update periodically, so that citizens need not file RTI applications for such information.

4. I, shall, therefore, be grateful if you could give instructions to the concerned officers for compliance of the directions of the CIC and make all relevant information available for general public/beneficiaries by uploading on the web site of the concerned Department and also by displaying on the notice boards of the Anganwadi Centres as mandated under Section 4 of the RTI Act. An illustrative list of information to be disclosed mandatory is enclosed for reference.

1. Name/No. of AWC
2. Name of functionaries (AWW/AWH/Supervisor/CDPO)
3. Details of benefits/services given to the beneficiaries;
4. Particulars of free supply of medicines or nutrients provided to beneficiaries with their names, dates;
5. Names and age of the beneficiaries;
6. Month-wise expenditure incurred on functioning and maintenance of Anganwadi Centres;
7. Minutes of the regular meetings;
8. Citizen charter
9. Timelines and availability periods for availing such benefits
10. Any other relevant information deemed necessary for the beneficiaries.
