



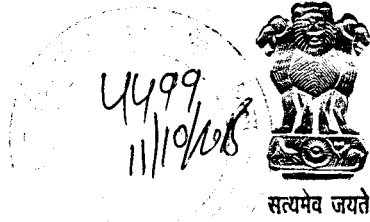

Dear Ms. Roli Singh,

Please find **enclosed** herewith a copy of the letter, dated 20<sup>th</sup> September, 2018 received from the Department of Social Justice & Empowerment (Ministry of Social Justice & Empowerment) requesting for necessary action on the recommendations of the National Commission for Denotified Nomadic and Semi-Nomadic Tribes. The part of the Recommendation No.15 (**copy enclosed**) pertains to Anganwadi Services under this Ministry.

2. The Anganwadi Services under the Umbrella Integrated Child Development Services (ICDS) Scheme is implemented by all States/UTs across the country with the objective to (i) improve the nutritional and health status of pre-school children in the age-group of 0-6 years; (ii) to lay the foundation of proper psychological development of the child; (iii) to reduce the incidence of mortality, morbidity, malnutrition and school drop-out; (iv) to achieve effective coordination of policy and implementation amongst the various departments to promote child development; and (v) to enhance the capability of the mother to look after the normal health and nutritional needs of the child through proper nutrition and health education.

3. These objectives are achieved by providing a package of six services by Anganwadi Workers (AWWs)/Anganwadi Helpers (AWHs), who are the frontline workers from the local community to deliver these essential services under the Anganwadi Services to the targeted beneficiaries, at the respective Anganwadi Centres (AWCs).

4. In this regard, I would like to request you to kindly issue necessary instructions to all concerned officers dealing with Anganwadi Services to take appropriate measures to reach out the isolated and far-flung areas where the Denotified Nomadic and Semi-Nomadic Tribes have their habitation and ensure that they are availing all the services available under Anganwadi Services.
