**::ORDER::**

In partial modification to the order No. F.15(12)Raj/Vad/06 dated 22-09-2015 the rates of Appearance fee and in partial modification to the order No. F.15(12)Raj/Vad/06 dated 04-09-2012 the rates of Drafting & settling charges payable to Advocate General and Additional Advocate General shall hereby stand revised from the date of issuance of this order:

**(A) Appearance Fees-**

**1. Advocate General:**

Rs. 2200/- per day up to five listed cases, but if the number of cases listed per day exceeds 5, then additional fees @ 600/- per case for the cases exceeding five shall be paid but in no case a total fees of more than Rs. 6900/- per day shall be paid.

**2. Additional Advocate General:**

Rs. 1750/- per day up to five listed cases, but if the number of cases listed per day exceeds 5, then additional fees @ 430/- per case for the cases exceeding five shall be paid but in no case a total fees of more than Rs. 4100/- per day shall be paid.

**(B) Drafting & Settling Charges-**

**1. Advocate General:**

Rs. 3500/- Per Case

**2. Additional Advocate General:**

Rs. 2600/- Per Case

Apart from per day appearance fee and drafting and settling charges as revised herein above, the other fee and charges shall remain same as prescribed under order No. F15(12)RAJ/VAD/06 Dated 26.10.2010 and departmental orders issued in this behalf from time to time.
