This is in reference to Government of India Scheme "Financial Support to MSMEs in Zero Defect Zero Effect Certification" launched by Hon'ble Prime Minister on 18.10.2016. The objective of the scheme is to assess, rate and handhold Indian MSMEs on ZED Maturity Assessment Model.

ZED Scheme is an integrated and holistic certification & handholding system, which can account for quality, productivity, energy efficiency, pollution mitigation, financial status, human resources and technological depth including design and IPR both in product and process of manufacturing. The Scheme envisages a robust certification process that consists of online self-assessment, desktop assessment and site assessment leading to certification. The handholding will provide an opportunity for MSMEs to strive to continuously improve their systems & processes thereby aiming to move up in the ZED certification system (Bronze-Silver-Gold-Diamond-Platinum)

This is first Indian model of its kind and needs to be supported so that MSMEs have a benchmarked Maturity Assessment Model. However, a brief write up about the scheme, FAQs and the scheme Guidelines are enclosed for ready reference.

Government of India has requested that the Departments and the public sector undertakings of the State Government should extend recognition and preference to ZED rated MSMEs. Government of Rajasthan has its own purchase rules for government procurements, including rules for giving preference to MSMEs of the state. Therefore, I request to give recognition to ZED rated MSMEs after having complied with prevailing rules of the State Government regarding government procurements.
